

## WAG 'N BIETJIE CAMP SITE

*This form needs to be completed in black ink. No changes may be made to any of the wording in this form. The original must be handed in upon arrival at the camp site. Completion of this form is compulsory in order to attend the camp at Wag 'n Bietjie.*

### PERMISSION, WAIVER, RELEASE AND INDEMNITY AGREEMENT: CHILD

In consideration of the Child named below ("**the Child**") being permitted to enter onto or utilize the property and facilities of Wag 'n Bietjie Camp Site ("**the Camp Site**") and to participate in any activities organized by or on behalf of the Camp Site or by a School at which the Child is enrolled, the undersigned, parent(s) or legal guardian(s) of the Child, on behalf of my/our heirs, executors, administrators and assigns, and on behalf of the Child, hereby agree(s) to the following terms and conditions:

1. **Participation:** Permission is granted for the Child to participate in the school organised visit and trip to and activities planned at the Camp Site from \_\_\_\_\_ to \_\_\_\_\_. I/We understand and acknowledge that certain risks are inherent in this type of excursion and I/we assume liability and responsibility for any such risks associated with participation in any such activities. All such activities and participation therein remain at own risk.
2. **Behavioural Expectations:** I/We understand and acknowledge that the Child is expected to abide by all reasonable rules and regulations of the Camp Site during the course of the visit. I/We agree that the owners and managers of the Camp Site have the right to terminate the Child's participation in the visit or any activities for any behaviour deemed detrimental to the Camp Site or other participants or to the Child.
3. **Early Return of Child:** I/We understand and acknowledge that, if the Child violates any rule or regulation during the course of the visit to the Camp Site or participates in behaviour that is deemed detrimental to the Camp Site or other participants or the Child, the Child may immediately be sent home.
4. **Acknowledgment of Risks:** Activities at the Camp Site may be hazardous and may include risks that are inherent to the activities and cannot reasonably be avoided without changing the nature of the activity. Participation in the activities can cause personal injury, including emotional trauma and possibly death. The Camp Site cannot foresee every possible contingency or completely eliminate all risk. I/We confirm that we have had opportunities to discuss the nature and the extent of the visit to the Camp Site with the officials of the School that has organized the visit to and activities at the Camp Site.
5. **Assumption of Risks:** I/We acknowledge and expressly assume all risks and dangers associated with all Camp Site activities, regardless of whether described above, are known or unknown or are inherent or otherwise. I/We take full responsibility for any injury or loss, including death, which the Child may suffer, arising in whole or in part from the enrolment and participation of the Child in the visit to or activities at the Camp Site.
6. **Hold Harmless:** I/We acknowledge that, as a condition of the Child's visit to or participation in any activities at the Camp Site, I/we hold harmless and waive any and all claims against the proprietors of the Camp Site, their officers, directors, trustees, volunteers, employees, agents and assigns, including, but not limited to, claims arising out of ordinary negligence of any officers, directors, trustees, volunteers, employees, agents and assigns of the Camp Site, or any loss or damage to personal property occurring during or by reason of the Child visit to or participation in any activities at the Camp Site.
7. **Voluntary Release of All Claims:** I/We voluntarily release, discharge, waive and relinquish all claims against the proprietors of the Camp Site, their officers, directors, trustees, volunteers, employees, agents and assigns arising out of or in any way related to the above described activities, including but not limited to, claims for bodily injury, personal injury, emotional distress, property damage or wrongful death occurring to the Child arising out of ordinary negligence during the visit to or participation in any activities at the Camp Site. This release, discharge, waiver and relinquishment also pertains to any instruction or supervision related to the visit to or participation in any activities at the Camp Site on the part of the proprietors of the Camp Site, their officers, directors, trustees, volunteers, employees, agents and assigns.

8. **Indemnification:** The Child and his/her parent(s)/guardian(s) further agree to defend and indemnify the proprietors of the Camp Site, their officers, directors, trustees, volunteers, employees, agents and assigns for any action or claim commenced by parent(s)/guardian(s) or on behalf of parent(s)/guardian(s), or for any action commenced by the Child or on behalf of the Child arising out of or in any way related to the above visit to or participation in any activities at the Camp Site, including but not limited to a claim for bodily injury, personal injury, emotional distress, property damage and/or wrongful death arising out of ordinary negligence during the visit to or participation in any activities at the Camp Site.
9. **Pre-Existing Medical Condition of Child:** I/We release proprietors of the Camp Site and their officers, directors, trustees, volunteers, employees, agents and assigns from all claims and liability for any illness, injury, loss of property and/or death resulting during or after the visit to or activities at the Camp Site from a pre-existing medical (physical, emotional and/or psychological) condition of the Child. I/We undertake to disclose fully any or all pre-existing medical condition(s) of the Child that may be relevant to the visit to or activities at the Camp Site. I/We accept full responsibility for omissions or errors in respect of such medical information or disclosure. To the best of my/our knowledge, the Child has no medical (physical, emotional or psychological) conditions that would interfere with his/her ability to visit the Camp Site or participate in the activities thereat or would otherwise endanger his/her health while participating in any such activities.
10. **Medical Care:** Any Camp Site officer, director, trustee, volunteer, employee, agent or assign is authorized to obtain immediate medical attention for Child. I/We consent to whatever examination, x-ray, anaesthetic, medical, surgical or dental diagnosis or treatment and hospital care are considered necessary in the best judgment of the attending physician, surgeon or dentist and performed by or under the supervision of the medical staff of the hospital or facility furnishing medical or dental services.
11. **Severability:** If any provision of this Permission, Waiver, Release and Indemnity Agreement is held to be invalid or unenforceable, the remainder of this agreement shall nevertheless remain in full force and effect.
12. **Entire Agreement:** This Permission, Waiver, Release and Indemnity Agreement constitutes a single, integrated contract expressing the entire agreement of the parties hereto. There are no other agreements, written or oral, express or implied, between the parties hereto, concerning the subject matter hereto, except the agreements set out herein. This Permission, Waiver, Release and Indemnity Agreement may be modified or superseded only in a written instrument to this agreement that specifically references this Permission, Waiver, Release and Indemnity Agreement and is executed by all parties.
13. **Voluntary Agreement:** The Child and the parent(s)/guardian(s) acknowledge that they have read this Permission, Waiver, Release and Indemnity Agreement and are aware of the legal consequences of signing this binding document. I/We have taken steps to become informed about the visit to the Camp Site and the activities planned thereat and certify that I/we are satisfied with the nature and quality of the visit as a voluntary activity for the Child. I/We have read this Permission, Waiver, Release and Indemnity Agreement. I/We understand that signing this agreement is voluntary and that I/we have been given the opportunity to seek legal advice and to question the contents before signing this binding document.
